Since this is a Full Professional Pack, please remove ANY personal effects you DO NOT want the movers to pack (ie, undergarments, jewelry, cash, valuables, personal effects)

Client: You ARE allowed to pack ANYTHING you wish on your own, the movers will mark these boxes "PBO" (packed by owner) in order to distinguish between the two. **KEEP IN MIND:** Anything you pack CAN NOT be insured by the 3rd party insurance company if you are purchasing additional insurance.

You are **ONLY** charged for the items you SHIP. We encourage our clients to **OVER** estimate the inventory list below so you have a "worst case scenario" since you are **ONLY** charged for actual items/volume NOT estimated items/volume.

Any additional items added after booking or any additional services added on/before move-out day will result in an additional cost given by the representative if prior or the foreman if on move day.

Please read the following requirements & regulations to ensure a smooth and worry free move.

Dedicated Van Lines Is PROUD to offer an array of additional services at your request.

Please speak to your representative in regards to questions/pricing for:

Box Delivery (prior to pickup), Maid Service, Unpacking Services (boxes) and Vehicle Transportation.

RESCHEDULE / CANCEL OF SERVICE: Rescheduling your move date must be submitted in writing to your representative at least 48 hours prior to your **first** available pick up date (not your backup date) . Cancellation of service: Reservation Deposits are refundable as long as cancelled 24 hours prior to first available pickup date. If you are moving within the next 12 months, you may keep the deposit on file and move on any date you wish with only 48 hours notice. All orders have a price-beat-guarantee to any other reputable carrier by \$250 up until your move day (meaning we will beat any other A+ companies price by a minimum of \$250 up until move date even after a deposit has been placed)

TERMS OF PAYMENTS: Upon booking, a deposit is required. We have several payment options available which can be discussed with your Relocation Coordinator. Upon pickup, 50% payment is due payable to the carrier. The remaining balance must be paid in full upon delivery via certified funds. (cc payments have a processing fee of 5% and must be approved in writing 48 prior.)

PACKING YOUR GOODS: Due to this quote being a Full Pro Packing Service, ALL Packing materials included but not limited to: mattress covers, picture boxes, tv boxes, dishpacks, wardrobes, larges/medium/sm boxes, plastic stretch wrap, bubble wrap, news print, etc are included at an UNLIMITED amount as long as your total box number does not exceed what is on your inventory list.

ESTIMATED TIME OF ARRIVAL TO YOUR PICKUP LOCATION: Dedicated Van Lines will provide an approximate time of arrival for your set pickup date. 24 Hour prior to the first available pickup date, a call/text/and email will be made by our dispatch team to confirm the arrival time of the driver as well as drivers direct contact information. Since this is transportation it is subject to change last minute so **please** be patient in waiting for your call 24 hour prior to confirm.

NOTE: If your apartment building requires a COI (certificate of insurance) we must FIRST receive a "sample coi" from the building with a MINIMUM of 7 days notice from pickup (in order to receive back from my ins company).

DELIVERY SERVICES: customer must be able and available to receive the goods starting the day after the goods were picked up unless noted otherwise in document above. . Any changes made by customer to their Ready Date may result in additional storage fees. We offer 30 Days Storage at a discounted rate (advise your representative if storage works for you). The charge for storage rent is \$0.40 per cubic foot per month. All estimated time of arrivals are subject to change depending on many industry factors such as traffic, weather conditions, unforeseen mechanical problems or unexpected delays with prior deliveries scheduled before you. Note: We can not discount any account due to any delays listed above. Our company will keep the customer informed verbally with a new / revised ETA (Estimated Time of Arrival) depending on company schedule.

ADDITIONAL FEES: This estimate is based on a flexible delivery schedule and normal access conditions at both pick-up and delivery locations (there must be access for a 48' or 53' tractor trailer with a maximum distance of 75 ft. from the truck to your door, and carrying up to 2nd floor stairs to avoid additional charges). In the event there is an excessive carry of anything over and above the first 75 feet, which is considered a "normal access condition", the customer will incur a charge of \$75 for every additional 75 feet increment. When moving out of an apartment and stairs are involved, there is a charge for any floor above the 1st flight (a flight is considered up to 10 steps). The customer will incur a charge of \$75 , per each additional flight . Lastly, if the customer's destination cannot accommodate a 53' tractor trailer, the customer will be charged a shuttle fee: up to 350 cft - \$350. 351 cft- and up-\$1.00 per cubic foot. Elevator one time fee is \$75.

CLAIM FILING PROCEDURE: As per company **TERMS AND CONDITIONS**, in the unlikely event a customer realizes that some of their goods are damaged or missing, or if they feel that they have been over-charged or charged for services that they didn't received prior, during or after services were completed, all customers **FULLY** understand that they **MUST** initially give the service provider (Moving Company) the **FIRST RIGHT** to fully investigate and respond in writing with a resolution to their issues.
