COMPANY TERMS & CONDITIONS:**Your basic full service move includes:**

1. Disassembling and reassembling of your basic wood or metal furniture only.
2. Wrapping and protecting of your wood or metal furniture ONLY with protective padded moving blankets at no additional cost.
3. Loading and unloading of your household goods on to and off of the truck.
4. All tolls, mileage, transportation fees and fuel are included!
5. Basic Valuation Coverage of 60 cents per lb.
6. 1 flight of stairs FREE OF CHARGE, Additional flights will be charged at the rate of \$75 per flight.
7. 1st 75 feet of long carry will be free of charge, each additional 75 feet will be charged at the rate of \$75 per 75 feet.
8. 1 month free storage at our storage facility.

Additional Charges: (Based on Individual move)

1. Additional flights of stairs are charged at a rate of \$75.00 per flight (single family homes are not charged for stairs inside home).
2. Long carry fees are charged at a rate of \$75.00 for every additional 75 ft.
3. Shuttle services, if there is no access for 48'- 53' semi-trailer at origin or destination will be based on total CF (\$250.00 minimum to \$750.00 maximum).
4. Packing materials for fragile items that are not disclosed during the original estimate quote will be charged based on the actual packing that is performed (service and materials).
5. Bulky items and/or handling fees - (Hot tubs, Motorcycles, Pianos etc. please ask rep) \$150 and up.
6. Additional storage will be charged at a minimum of \$150.00 per month or 0.35 cents per CF, whichever is greater.

Full packing services include:

All boxes, tape, and materials that are needed pertaining to the itemized inventory list previously submitted ONLY! The company will pack china, clothing, TVs etc. Should you require additional packing services, additional charges may apply! Please feel free to revise your list by adding or deleting items up to 72 hours prior to the move only. (Sales reps cannot access your account within the 72 hours).

Terms of your estimate:

1. Your quote is based on the list of items/inventory that you have provided below. Please feel free to call your representative up to 72 hours prior to your pick-up to make any adjustments to the list. (It is highly recommended).

2. Any additional items or adjustments that you may have on pick-up day that are not listed or were not disclosed to us during the quote will be charged additionally based on the items added to the list/truck. Changes made to the list on the pick-up day will result in your shipment being re-evaluated and the driver will present you with a new revised binding quote. Additional items added will be subject to an additional charge of up to \$3.00 added to the original estimate price per cuft.

3. The shipper understands that all loose items must be packed in boxes. Loose items such as plastic bags of any kind, trash cans, hampers etc. will not be accepted or shipped.

4. Our moving trucks are fully equipped with materials and supplies that are needed and are available upon request for an additional charge (UNLESS FULL PACKING IS DISCLOSED IN QUOTE IN ADVANCE).

PAYMENT TERMS:

1. There is a 30% deposit required for reservations payable via Check, Money Order, Zelle, CashApp, Wire transfer or direct deposit to the company's account.

2. 50% of the total bill is due upon pick or before the items leave the origin state (not including deposit payment).

3. The remaining balance is due upon delivery PRIOR to unloading in the form of US Postal Money Order, Zelle, CashApp, Wire transfer ONLY.

****At delivery, payment forms are as follows only: Postal Money Order, Cash or Money transfers (Zelle, CashApp, Wire transfer or direct deposit to the company's account). *Using a credit card will be subject for approval and an additional 3% convenience fee (accepted at pick up ONLY and subject to approval).

4. *CANCELLATIONS MUST BE MADE IN WRITING VIA EMAIL AT LEAST 72 BUSINESS HOURS PRIOR TO YOUR MOVE DATE OTHERWISE YOUR DEPOSIT WILL BE FORFEITED AS A CANCELLATION FEE!*****
