- 1. Packing supplies such as boxes, bubble wrap, shrink wrap, packing paper, crates, etc.
- 2. All cabinet, dresser drawers MUST be emptied out before being loaded onto the truck.
- 3. Garbage bags will NOT be accepted due to their delicate integrity and will NOT be loaded onto the truck unless boxed.
- 4. Washer, dryer, ceiling fan, televisions or any other electronics MUST be unhooked/ unplugged prior to arrival. Kings Moving Services does NOT hook up any of the above items.

- 5. Cribs, bunk beds MUST be disassembled prior to arrival. By law, Kings Moving services does NOT reassemble cribs and bunk beds
- The following items MUST be boxed or crated either by you or by Kings Moving Services at an additional cost. For a list of these charges, consult with your moving consultant. Any Safes, tool boxes over 300 pounds; you must notify your customer service representative immediately.

#### **Payments and Methods Of Payment:**

- A deposit of 15% is required upon reservation by credit card, cash or check by mail. This sum will be deducted from the final cost
- 60% of the total cost balance will be paid upon pickup and 25% upon delivery; if a shared regular delivery, credit
  card(upon approval by company), cashier's check, postal money order, money wire. If an express move; 65% of the
  total cost balance upon pickup and balance at delivery. This payment must be paid no later than 72 hours from your
  pick up date otherwise a late fee of \$75 will be added to your bill as well as \$25 per day from the 4th day.
- The final balance will be paid upon delivery and prior to off-loading by cash, credit card, cashier's check or postal money order only. In the case of final payment by credit card, you must pay the balance on the day that your delivery ETA is provided to you by one of our representatives. There will also be a 4% service fee for using a credit card for the remaining balance which you can avoid by paying with a different method of payment, such as cashiers check, money order or cash. If using a credit card or debit card for payment, client gives permission to pay the invoice in full anytime after completion of move.

#### **Delivery Schedule:**

The delivery process will begin from your first available date to accept the goods and NOT from the pickup date. Because nationwide moving companies consolidate their moving shipments, delivery general time frame by law is up to 21 business days from your first available date to accept your goods. Kings Moving services strives to deliver in a time frame of 1-14 business days from you first available date to accept your goods. Please be advised that unforeseen errors might occur such as bad weather, traffic, road conditions, mechanical breakdowns and issues with earlier drop-offs which may delay subsequent deliveries.

There are NO guaranteed delivery dates due to the circumstances referenced above as well as the Truck routes we take.

Choose Your Pickup Date Carefully:

In order to safely avoid any scheduling conflicts with your personal arrangements, Kings Moving Services highly recommends NOT to schedule a flight or make similar travel plans on the same day of your move.

While Kings Moving Services will always take great pains to honor the scheduled commitments to you, several factors may occur that may affect our estimated time frames of arrival at your pickup location such as bad weather, traffic, road conditions and mechanical issues. Any claims must be in writing; sent in an email and or postal correspondence requesting a claims form.

To that end it is important that you request from us a pickup date that is no closer than 24 hours before embarking on any travel, possible time conflict commitments you have made and/or the date you have agreed with your landlord or realtor to vacate you premises.

Kings Moving services will NOT be held responsible for missed flights, re-scheduling flights or any fees that might occur.

## Kings Moving Services No Hidden Cost Policy:

- Stairs: The first flight of stairs (up to 15 steps) is free of charge. Each additional flight of stairs (up to 15 steps) would be charged \$75 per flight of stairs.
- Elevator: If Possible, reserve an elevator in the building for the time when your belongings will be loaded or unloaded from the truck. A onetime fee of \$75 will be applied to your final cost for using an elevator up to 10 floors and \$150.00 over that
- Long Carry: If the distance between the truck to the entrance of your home is more than 75 feet, the movers are not
  required to take the shipment inside unless you pay an extra fee. The first 75 feet are at no charge and each additional
  75 feet would be charged a onetime fee of \$75 and \$1.00 per foot thereafter. To avoid such a charge and troublesome

- Low overhead wires, tree limbs, or structures. Although Federal law requires that all roadways be clear of any
  overhead structures which sit lower than the 13-feet 6-inches there are often instances in which this law is not
  observed.
- Sometimes there are man-made features (such as water fountains in the middle of a roundabout) which block the
  movement of large trucks.
- Narrow roads or driveways with tight turns prevent access by large trucks.
- Very old low bridges or underpasses.
- Tight turns in apartment or condo complex parking lots.
- Weight limitations and or size limitations.

Bulky Items (\$150.00): denotes any Items that cannot be stacked on top of or beneath. It's a special Item that is
awkwardly shaped and typically extra large in size. (i.e treadmill, canoe, extra fragile floor based\* items etc.) - piano
handling fee: upright - \$150; baby grand - \$250; grand and over-size - please advise sales rep. (these do not include
packing or the weight of the item) -motorcycle handling fee- \$250 (these do not include packing or the weight of the
item)

#### Ownership of goods:
