Our moving staff consists of all professionally trained, uniformed, movers who are experienced in the packing and handling of all of your belongings. All local moves have a minimum of (3) hours of labor + (1) hour of travel time.

The estimate is based on the information you have provided and/or the items listed in the inventory list.

The labor time:

Begins from the initial arrival time at your first location and covers the total time of the move: The loading and driving to your new location and the unloading are included in the total labor time.

Travel time:

Charge covers the mover's costs for traveling from their facilities to your location and back to their facility once the move is complete.

## This Quote includes:

1. Door to door service.
2. Fully equipped truck (16 or 26 ft).
3. Professional moving crew (Loading, transportation and unloading.)
4. Total will be based on actual labor/work time from time start to time finish.

Full Packing Service:

Packing Materials and supplies:

Please note packing materials (boxes, paper, tape, mattress cover, shrink wrap, bubble wrap, etc) are NOT included and will be charged as used on your move per item used.

(Not applicable for full packing service moves)

Please Note: in order to protect your belonging and to satisfy our liability coverage, it is required that all breakable items must be protected prior to loading. Wood furniture will be blanket wrapped. Upholstered furniture and mattresses needed to be shrink wrapped to avoid soiling. Glass pieces should be bubble wrapped and boxed. All other household goods must be packed in boxes.

Storage:

One month in our storage facility is free with your move. All storage charges are on a monthly basis.

If going into storage, please take into consideration the time to unload into storage and reload back from storage.

We also charge one time rental fee of \$6.00 per moving blanket that may be used to protect your belonging while in storage.

Storage out:

When you are ready to move out of storage, call us to schedule your move out.

The move out from storage is a separate move from the move in and will be performed at the current seasonal rate.

Filling Claims:

All claims MUST be submitted in writing via US Mail for any loss, damage, complaint or delay to the address listed on this estimate service within 3 months of the delivery date.

Valuation:

Released value of \$0.60 per pound/per article, up to a maximum of \$50.00 per item. In the event that an article is lost, destroyed or damaged while in our movers' custody, BR MOVERS' liability is limited to the actual weight of the lost, destroyed or damaged article multiplied by "60 cents per pound/per article".

This is the basic liability level which is included with any move.

**Form of Payment:**

A deposit of \$100.00 from the Quote is required when scheduling the move date. The deposit will be applied to the move and deducted from the total cost of the move.  
The remaining balance is due upon delivery by credit/debit card, cash or postal money order ONLY. We do not accept personal/business checks.  
Payment due on the move day, prior to unloading the truck. **Note:** 5 % of the total moving cost will apply as a processing fee.

**Cancellation policy:**

To reschedule your move, you must notify us at least 72 hours prior to the move date. Your move will be rescheduled based on our availability.  
Cancellation of your move must be 72 hours prior to the move date, and must be in writing through e-mail or fax, otherwise a \$200.00 cancellation fee will apply.
