This rescission of the original estimate and new visual estimate supercedes all other estimates and controls as the current estimate. I hereby request that any and all previous estimates be rescinded because I have significantly altered the circumstances surrounding my move from which I first requested an estimate. This revised written estimate, in accordance with 49 CFR 375.403(a)(5)(ii) and 375.405(b)(7)(ii), is only valid if fully executed before any work begins. Packing material and labor are not included and will be charged per items ordered and listed on the packing materials price list. On interstate moves an 18 wheeler may be used to deliver the property. If the destination address does not have access for an 18 wheeler the shipper will be required to pay for shuttle service. For all estimates there may be additional charges for flights of stairs, elevators, extra drop-offs or pick-ups, re-delivery, long carriers, and shuttles for residences in restrictive complexes. This new estimate is rate based on the weight or cubic feet that were estimated. If non-binding, the total charges are based on the actual weight of the property and may exceed the estimate subject to the 110% rule; maximum amount demanded at time of delivery is the amount of the non-binding estimate plus 10%. If binding, then total amount of the binding estimate (100%) must be paid in full prior to unloading. Additional charges will incur for services performed after the estimate is given and billed after 30 days. LIMITATION OF LIABILITY: Unless the shipper expressly releases the shipment to a value of 60 cents per pound per article (an article is each item on the inventory and not each item within a box) carrier's maximum liability for loss and damage shall be based upon the FVP Replacement option. Under, this option the mover is liable for the replacement value of lost or damaged goods (as long as it doesn't exceed the total declared value of the shipment). If you elect to purchase full value protection, and your mover loses, damages or destroys your articles, your mover must repair, replace with like items, or settle in cash at the current market replacement value, regardless of the age of the lost or damaged item. Minimum declared value of a shipment under this option is \$5,000 or \$4.00 times the actual total weight (in lbs.) of the shipment, whichever is greater. The total amount of the non-binding estimate plus 10% must be paid in full prior to delivery and unloading. Additional charges will incur for services performed after the estimate is given. Minimum charge will be charged at 2,000 lbs.; or its equivalent in cubic feet. All charges are based on full tariff rates. Carrier's Tariff is available for inspection upon request. (Carrier's Tariff)

FORM OF PAYMENT: Upon booking a deposit will be due in the form of Visa, or Mastercard. Upon pickup 50% of the estimate is due in the form of Cash, money order, certified check or personal check. Personal checks will only be accepted if there is at least 10 days between the scheduled pickup and delivery dates. Prior to unloading the balance is due in the form of CASH or POST OFFICE MONEY ORDER ONLY. The Carrier reserves the right to collect up to 75% of balance due prior to the goods leaving the origin state. Subject to federal law, payment in FULL of all charges is required before delivery and prior to unloading - Subject to the 110% law, if applicable. All charges are based on full tariff rates.
