

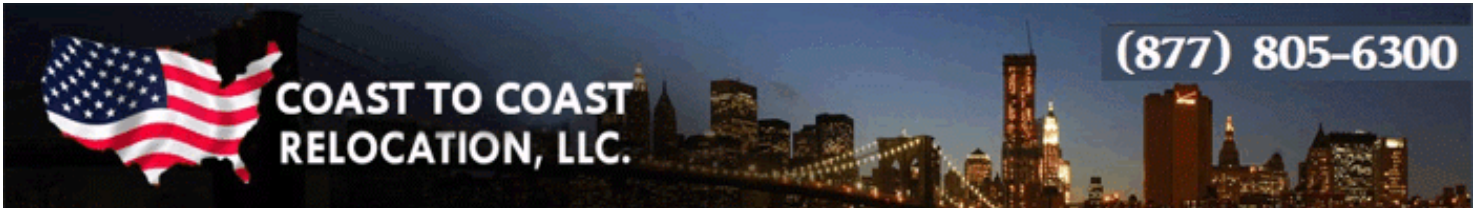

THIS IS A BINDING-NOT-TO-EXCEED ESTIMATE BASED ON WEIGHT OR CUBIC FT. IF THE LOAD WEIGHT/CUBIC FT IS HIGHER THEN THE ESTIMATE, THE CUSTOMER SHALL PAY THE SAME RATE PER LB/CUBIC FT AGREED UPON AT BOOKING. IF THE LOAD WEIGHT/CUBIC FT. IS LESS YOU WILL RECEIVE A CREDIT OF THE DIFFERENCE. **(MINIMUM OF 3,500 LBS/500 cubic ft APPLICABLE)** .

**Elevator fee** \$75.00 per each stop or origin/destination location. **Stairs** (first flight (8 steps) free, inside flights in single family home no charge). Each additional flight \$75.00

**Long Carry** (for example: From where our truck is parked to your door, if it's 75 feet or more, an additional charge of \$75 per each 75 feet will apply).

**Additional Packing** : IF the "FULL pack" was not selected, packing materials like bubble wrap, boxes, tape, shrink wrap, mattress covers, glass crates, TV crates, etc. are an extra cost. packing materials will be charged solely based on what will be used for your move and according to the packing material order form. On the Full Professional Packing service packing materials and labor for the weight over the estimate will be charged according to full tariff.

**Shuttle service** (varies): A shuttle is required at destination points that cannot accept an 18 wheel semi-trailer. Most situations don't require a shuttle, however if it is required, it will be charged at \$1/cubic foot to transfer your items, with a minimum of 350.00.

**Bulky item** (\$150.00) : denotes any items that cannot be stacked on top of or beneath. It's a special item that is awkwardly shaped and typically extra large in size. (i.e treadmill, canoe, extra fragile floor based\* items etc.) - piano handling fee: upright - \$150; baby grand - \$250; grand and over-size - please advise sales rep. (these do not include packing or the weight of the item) -motorcycle handling fee- \$250 (these do not include packing or the weight of the item)

**Storage:** One month of free storage in our secured facility is included and available per customers request at origin. (load/unload fees may apply). Time in storage will be charged at a monthly rate of \$100/1500lbs(minimum \$200 apply) To stop storage fees please notify the office 10 days before storage expires, or next months storage fee will apply. Storage fees are not pro-rated. **IF not noted otherwise on the contract.**

**CANCELLATION POLICY-ONCE RESERVATIONS HAVE BEEN MADE WITH COAST TO COAST RELOCATION, DEPOSITS ARE REFUNDABLE IF IN WRITING AND MORE THAN SEVEN BUSINESS DAYS PRIOR TO FIRST SCHEDULED PICK UP DATE. TO FINALIZE THE REQUEST YOU NEED TO CONTACT OUR CANCELLATION MANAGER.**

I agree to pay the total charges for moving services to be provided by Coast To Coast Relocation (the "Company"). I understand that my deposit/fee represents only a portion of my total estimated service charges. I understand that if I cancel my move less than 7 days prior to the scheduled pack or load date and the truck has not arrived at the pick-up location than I am only entitled to receive a credit of my deposit for future interstate moving services to be used by the cardholder within a 12 month period from the date of cancellation. If I cancel my move less than 7 days prior to the scheduled pick-up or load date and the truck has arrived to attempt services then I am not entitled to a refund or a credit of my deposit/fee. All credit card refunds will be processed on my next billing statement.

**Methods of payment:**

- a) A Security Deposit is required at the time of booking to schedule your move day.
- b) 50% of the total balance is due at the pick up date via cash, personal check\*, cashier check\* or Money Order. \*we will not accept any checks if there is less then 7 days between the pick up day and the delivery day.
- c) All of the remaining balance is due upon delivery via **CASH or POSTAL MONEY ORDER ONLY**.
- \*Please note: If payment is returned to us as NSF; The first month's storage will apply to your total charges, a fee of \$50 for the NSF will be necessary, and full payment for total contracted amount will be required prior to delivery.

#### Summary of dispute settlement program:

The neutral arbitration program has been designed to give neither party any special advantage. If a dispute arises between the carrier and the shipper arbitration may be mutually beneficial alternative to help resolve the dispute. Section 49 U.S.C. Section 375,211 provides that a mover must have a program in place to provide shippers with an arbitration alternative. Arbitration is an alternative to courtroom litigation. It provides each party to the dispute to present their cases and allows a neutral third party arbitrator to make a decision as to the merits of each side's case. Arbitration subject to this agreement shall be conducted via written submission and, subject to the arbitrator's discretion, through telephonic appearance. After the initial filing fees have been paid and the arbitrator selected, the initiating party or "claimant" must submit a written brief summarizing their legal position or factual claims. All supporting documentation must be included with the initial arbitration brief. Copies of all documents must be submitted to all parties involved in the arbitration. Upon receipt of the claimants arbitration brief and supporting documents, the responding party or "respondent" will have 30 days to file their responsive arbitration brief and the supporting documentation. Further deadlines and timetables are subject to the arbitrator's discretion. **Legal effects:** if the arbitration alternative is chosen, then any decision made by the arbitrator may be binding. Additionally, an arbitration decision may not be appealed in a court of law. All parties agree that the Arbitrators decision will be based exclusively on the governing United States Federal Law without regard to conflicting State laws or regulations. **Applicable costs:** each party is responsible for their own costs associated with the arbitration. A benefit to the arbitration alternative may be that it is less expensive than traditional litigation. Each party is responsible for 50% of the costs for securing the arbitrator and 100% of their own expenses, including but not limited to attorney fees. Call carrier for forms and more info. Arbitration will be conducted by Transportation ADR Council, Inc.

#### Ownership of goods:

Shipper has represented and warranted to the carrier that it is lawful possession of any legal right and authority to tender all of the property herein and that there are and will be no liens, mortgages, or encumbrances on said property superior or adverse to the legal right and authority of shipper to contract for services and id there be any litigation concerning the property, the shipper agreed to pay all storage and other together with costs and expenses, including reasonable attorney's fees which this carrier may be reasonably incur or become liable to pay in connection there with. This carrier shall have a lien on said property for charges and for such costs and expenses. Shipper agrees to indemnify the carrier with regard to any costs and expenses including but not limited to attorney fees, with regard to a claim of ownership and/or possession made by and third party with regards to the goods specified herein.

#### Exemptions to carrier liability:

Neither the carrier nor vessel shall be responsible for loss or damage arising or resulting from (a) Act of God; (b) Act of War; (c) Act of public enemy; (d) fire, unless caused by the actual fault or privities of the carrier; (e) perils, dangers, and accidents of the sea or other navigable water; (f) inherent defect, quality of vice of goods; (g) goods packed by shipper; (h) any other cause arising without the actual fault or privity of the carrier. Additionally mechanical vehicles including but not limited to automobiles, motorcycles, scooters, boats, airplanes, atvs, go-carts, riding lawnmowers, tractors, and other similar vehicles are transported at the sole risk of the shipper since all coverage for those items is waived against the carrier, its agents or representatives. The carrier shall not be held responsible for any items insisted by shipper to be moved through impassible passageways or other impassible openings.
